BUILDING SIGNAGE AND FACADE CHANGES



The majority of the downtown buildings are located within the Heritage Conservation District. New signage and façade changes will require a permit.

HERITAGE PROPERTY GRANT



The St. Marys Designated Heritage Property Grant Program is available to owners of heritage designated properties in the Central Commercial District. The program is designed to assist property owners in the conservation and preservation of the Town's built heritage resources.

EMPLOYEE PARKING



There are over 250 parking spaces downtown. The limit for on-street parking is three hours. A parking ticket will be issued to anyone parked in the downtown core for longer than the allotted three-hour limit.

Extended duration parking can be accessed by your employees at one of the three municipal lots: Water St. N, Jones St. E, and the lot on the north side of Elgin St. E across from Canadian Tire (enter from Water St. or Wellington St.).

The Town of St. Marys is committed to encouraging economic development and tourism in the downtown core. Having seasonal street patios, bistro tables and retail displays in the downtown provides a unique experience for both tourists and locals.

The Town takes pride in prioritizing accessible sidewalks and has parameters and guidelines on road allowances to ensure compliance with both the Accessibility for Ontarians with Disabilities Act and the Ontario Fire Code.

A seasonal occupancy allowance for street patios, bistro tables and retail displays can be obtained through a yearly application process.



ST. MARYS MONEY REIMBURSEMENT



- You will accept St. Marys Money like regular cash. If a customer requires change from a St. Marys Money bill, you will give the change in regular cash.
- Please make all staff aware that the business accepts St. Marys Money and the process to do so.
- You will then bring the St. Marys Money you have received in an envelope to Town Hall. Please write the following on the envelope:
 - Business name
 - Mailing address (where the reimbursement cheque will be sent to)
 - Amount in the envelope
- In lieu of writing out the information above, you can include a business card with the information in the envelope.
- You can bring the St. Marys Money to Town Hall for reimbursement at any time during business hours (8:30 am – 4:30 pm). There is no certain amount you need to have before you bring it in for reimbursement.
- You will receive a cheque for the amount of St. Marys Money you handed in via mail within 7 10 business days.
